

## Open Call International Artist Residency 2024

The Art House (TAH) and the Royal Over-Seas League (ROSL) are offering a residency based in the UK in 2024.

We are looking for artists living and working in a commonwealth, or former commonwealth country, the US, EU and EEA countries or Switzerland. It is also open to an artist living and working in the UK, with connections to/originally from these countries

We encourage artists who have not yet exhibited or worked in the UK, or who are looking to raise their profile and practice in the UK.

We are seeking proposals from artists who would like to have a two-month supported residency. It will be based in Wakefield.

It is designed to help develop the practice of artists working internationally who have not yet worked or exhibited in the UK. It is also designed to help those living in the UK, but who would like to increase their profile.

You will not be required to make an object or exhibition, but you will receive curatorial and technical advice if required. We are keen to support two artists, staying with us at the same time.

### **The residency offers:**

- Fully covered travel and visa costs.
- Living costs covered with a daily expenses.
- A studio and accommodation in The Art House.
- Access to a Print Studio, with screen print and etching facilities.
- Access to a Ceramic Studio and a Darkroom – with support from an onsite technician.

- Material budget.
- UK travel budget between London and Wakefield.
- Production of a film to document the residency.
- Coaching and mentoring with the Programme team (we will look at artists' support needs at the start of the residency)
- A supported and funded visit to London for a week. You can stay in stay central London. We will support you to see art in London.

## **Proposals**

Proposals are welcomed from artists working in all types of art, including photography, film, sculpture, performance, crafts, design, architecture.

We are accepting proposals from artists at all stages of their development.

Shortlisted artists will be asked to join an online conversation with the team to explore what they would like to do for this residency, and what support may be needed

We are happy to discuss flexibility if any aspect of the offer needs adapting to suit your needs.

## **How to apply**

The deadline is 10pm (UK time) on Thursday 25 April, 2024

Your proposal does not need to be fixed. It can change during the course of the residency.

You can make applications via written text, audio or video. You can choose what you feel is best.

You only have to choose one of the options below:

**Written text applications** – send a PDF of no more than 5 pages. Please include images within the 5 pages.

**Video submission** – send a short video, no longer than three minutes. Please send over with no more than 5 images of your work

**Audio submission** – send a short audio mp3, no longer than three minutes . Please send over with no more than 5 images of your work

The residency will take place between **September–November 2023**.

### **Helpful prompts/points to consider when applying**

You may like to include:

- A simple outline, telling us what you would like to do and what in development as an artist you want to get.
- A statement describing your artwork and practice.
- A selection of images relating to the proposal, such as previous or artwork
- A brief statement about your commonwealth (or former common wealth), US, EU, EEA or Switzerland connection.
- Information on any barriers you have faced, past or present (gaps in your practice or CV will not affect your application)
- Your contact information.
- Links to your website or your social media and your CV.

If you have questions about our criteria please contact us. Your privacy are important to us. We will comply with data law. Your personal data will not be shared with anyone, and will only be used by the TAH and ROSL team to shortlist the proposals.
